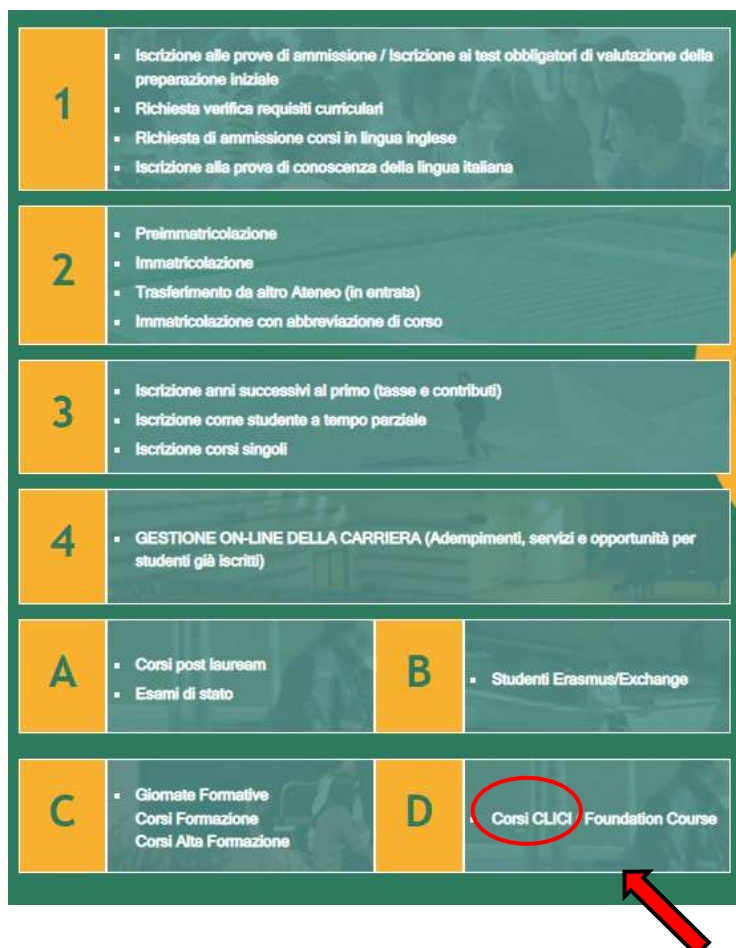


## Registration procedure for Summer School Students

1. Access Delphi platform (link: <https://delphi.uniroma2.it/totem/jsp/index.jsp?language=EN>) and click on "Student section"



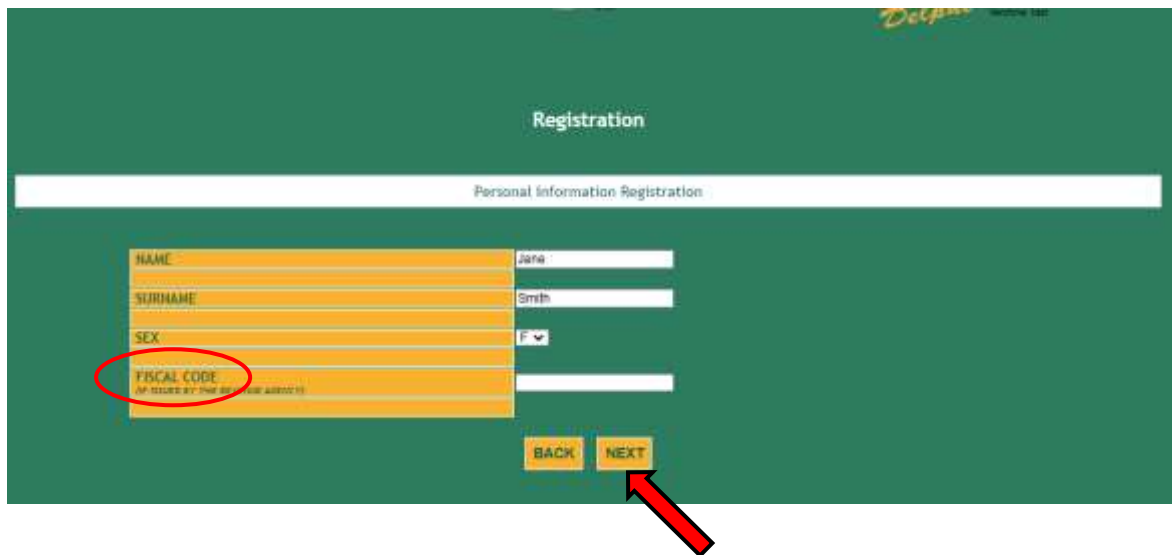
2. Select "CLICI Courses" in section D



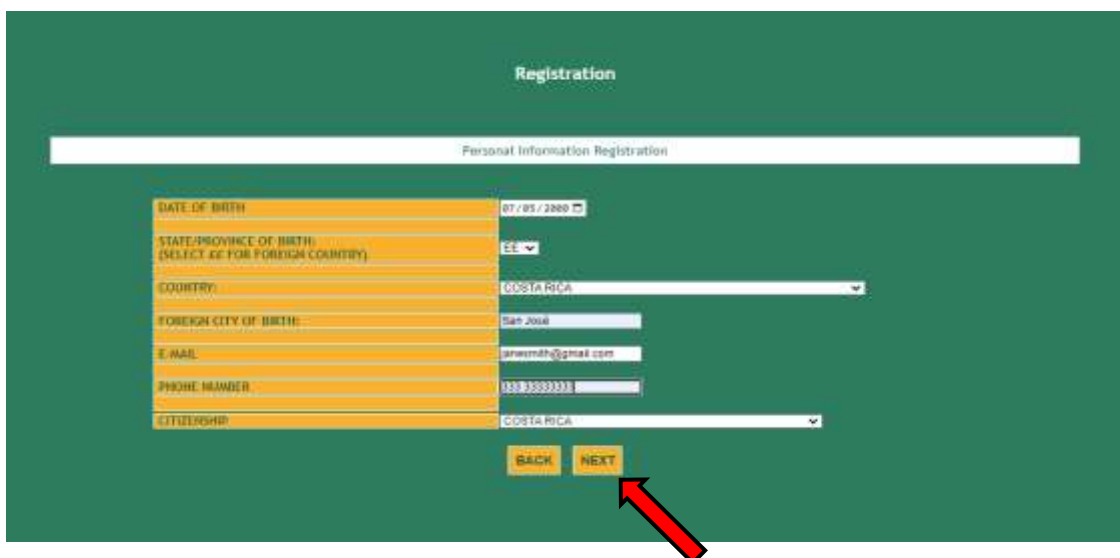
3. Select "Registration"

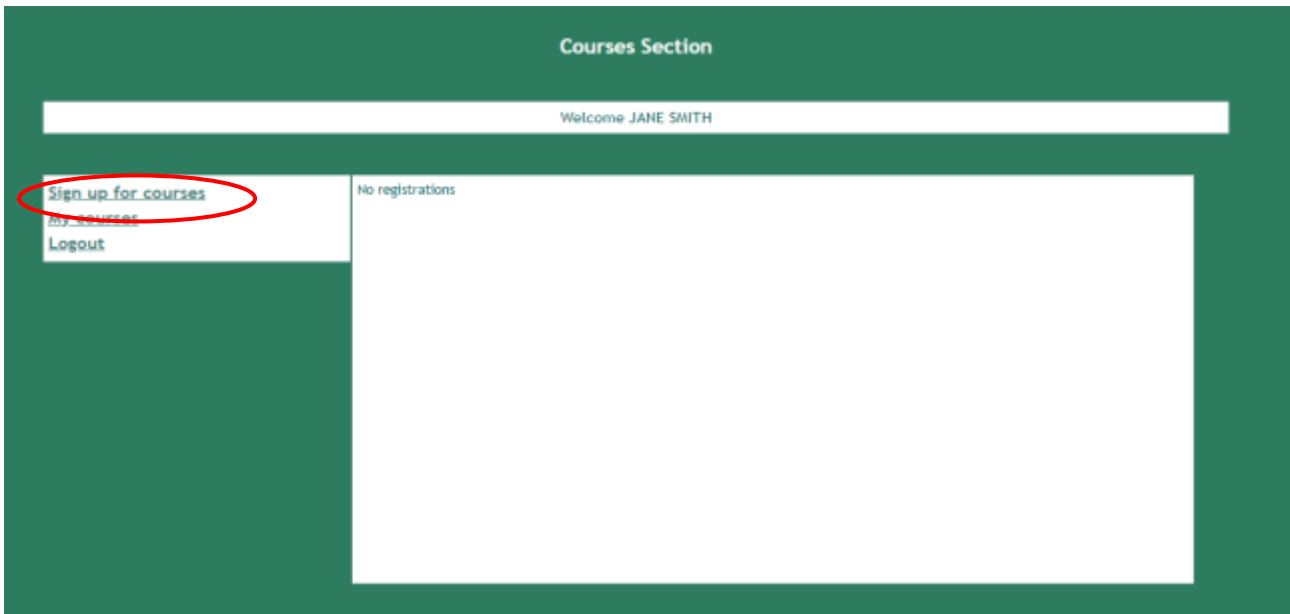

<b>2. Data subjects and Personal Data collected</b>	<p>The University of the Studies of Rome "Tor Vergata" - through the CLICI - processes personal data for the purpose of organizing and conducting specific activities of CLICI (Italian language and Italian culture courses, cultural activities and language study) as well as other events (Clici#Tandem, CLICI Language Café, CLICI Summer School, etc.).</p> <p>Data subjects are:</p> <ul style="list-style-type: none"> <li>- University teaching staff (professors and/or researchers);</li> <li>- technical, administrative and libraries staff of the University (TAB);</li> <li>- students not of Italian mother tongue enrolled at the University (bachelor or master courses, Erasmus students, YUFE students, doctoral students, etc.)</li> <li>- students not of Italian mother tongue enrolled at other partner universities (as an example YUFE students);</li> <li>- high school students;</li> <li>- other individuals non belonging to the university community.</li> </ul> <p>Personal data collected:</p> <ul style="list-style-type: none"> <li>- first name, last name, place and date of birth, gender, citizenship, social security number, address;</li> <li>- e-mail and telephone number;</li> <li>- identification document (ID card or passport);</li> <li>- mother tongue and other language proficiency level.</li> </ul>
<b>3. Source of personal data</b>	Personal data are collected directly from the data subject at the time of application submission.
<b>4. Purpose of data processing</b>	Personal data collected is used for <b>didactic-training purposes</b> and, specifically, for the purposes of enrolling in and carrying out Italian language and culture courses - which can also be delivered in on-line mode - and participation in cultural and in-depth linguistic activities organized by CLICI. Personal data will be processed pursuant to Article 6(1)(c) ("fulfillment of a legal obligation to which the Data Controller is subject") and 6(1)(e) ("performance of a task carried out in the public interest") of the GDPR. The legal basis for the processing is L.341/1990, L. 240/2010 and other specific regulations on the subject. The Data Controller does not use automatic processes aimed at profiling the Data Subject.
<b>5. Recipients of personal data</b>	The data processed for the abovementioned purposes will be communicated and/or made accessible to employees and collaborators assigned to the relevant University Offices, in their capacity as authorized subjects for processing. In the event that the personal data are communicated to third parties who operate processing on behalf of the University, they will act as Data Processors.
<b>6. Data Retention Period</b>	For the pursuit of the abovementioned purpose of data processing, the retention time of personal data is set at a maximum of ten years from the conclusion of the educational course undertaken and/or the cultural activity carried out (and other specific events curated by CLICI).
<b>7. Data Subject's Rights</b>	<p>The data subject has the right to:</p> <ul style="list-style-type: none"> <li>- request from the Data Controller (by writing to e-mail <a href="mailto:ret@uniroma2.it">ret@uniroma2.it</a>), pursuant to Article 15, 16, 17, 18, 19, 20 and 21 of the GDPR, access to his/her personal data and the rectification or erasure of the same or the restriction of the processing concerning him/her or to object to its processing, as well as the right to data</li> </ul>
